4. Activity of the budgetary organisation

4.1. Public duty of the budgetary organisation:

NKFI Hivatal (Office) performs public duties related to the public funding of research, development and innovation.

NKFI Hivatal (Office)

- a) shall prepare government decisions concerning the mid-term scientific research, development and innovation strategy and contribute to its implementation,
- b) shall be responsible for the National Research, Development and Innovation Fund (hereinafter: NKFI Alap (Fund),
- c) within the scope of responsibilities as the organisation managing the research, development and innovation tenders financed from the NKFI Alap (Fund), shall
 - ca) publish calls for proposal, organise and carry out the assessment of applications and the decision-making in line with the call, and decide on awarding funds,
 - cb) issue subsidy deeds and conclude subsidy contracts,
 - cc) monitor and control awarded proposals,
 - cd) perform planning, data provision and reporting tasks of the NKFI Alap (Fund),
- d) shall make decisions on providing national public funds from the NKFI Alap (Fund) based on laws, government decrees, government decisions, international treaties or individual applications,
- e) shall participate in the Monitoring Committee of the Economic Development Operational Programme implemented with the co-financing of the European Union in the period between 2007–2013,
- f) as set out in the agreement signed with the relevant managing authority, shall cooperate in carrying out certain tasks related to budgetary funds provided within the framework of the Economic Development and Innovation Operational Programme and the Competitive Central Hungary Operational Programme in order to achieve objective no. 1 of the Partnership Agreement, with special regard to:
 - fa) preparation, publication, modification and suspension of call for proposals,
 - fb) evaluation of claims for funds in regards of form and content,

- fc) preparation of funding decisions,
- fd) issuance and withdrawal of subsidy deeds, conclusion and termination of subsidy contracts, performance of tasks related to the termination of the contract, modification of the subsidy deeds and subsidy contracts,
- fe) assessment and monitoring of tasks following the implementation of the funding objectives,
- ff) evaluation of whether payments made on the basis of reports and partial reports are justified,
- fg) performance of audit-related tasks,
- fh) investigation of irregularities,
- fi) record-keeping and management of claims,
- g) shall perform the professional tasks related to international and/or European integration cooperation in the area of research, development and innovation,
- h) shall participate in the use and coordination of foreign funds provided to Hungary for purposes of research, development and innovation, shall cooperate with the central organisation established for the same purpose in order to promote investments in Hungary in the field of research and development,
- i) shall contribute to the implementation of the EUROPE 2020 Strategy 'Innovation Union' programme,
- j) shall carry out tasks related to international scientific and technological cooperation, based on legal regulations or international agreements,
- k) shall promote the innovative activities of micro, small and medium-sized enterprises in order to enhance their competitiveness,
- l) shall prepare analyses, assessments and concepts to substantiate the programme strategy and planning of national research, development and innovation funding programmes including the NKFI Alap (Fund)—, monitor and assess the funding schemes,
- m) shall support conferences, fairs, publications directly related to research, development and innovation activity, the development of electronic information databases and libraries as well as awards for research, development and innovation.

NKFI Hivatal (Office) shall be responsible for the National Research, Development and Innovation Fund established as the legal successor of the Research and Technology Innovation Fund (KTIA), as of 1 January 2015.

5. Organisation and operations of the budgetary organisation

5.1. Appointment of the leader of the budgetary organisation: The President of NKFI Hivatal (Office) shall be appointed and dismissed by the Prime Minister, the term of appointment is 5 years. The same person shall not be appointed as President of NKFI Hivatal (Office) for more than 2 occasions. Further employer rights over the executive officer of the budgetary organisation shall be excercised by the Minister of the Prime Minister's Office.
