1. PURPOSE OF THE CALL

Announced by the Ministry for Culture and Innovation as funder (hereinafter "Funder") through the National Research, Development and Innovation Office as technical coordinator (hereinafter "NRDI Office" or "Technical Coordinator") from the National Research, Development and Innovation Fund (hereinafter "NRDI Fund"), HU-RIZON INTERNATIONAL RESEARCH EXCELLENCE COOPERATION PROGRAMME aims to provide support for international collaborative projects led by Hungarian higher education institutions that seek innovative solutions to challenges relevant and topical for the Hungarian and international community, in line with the focus areas of the John von Neumann Programme (NJP). The call will contribute to:

- the implementation, through the concentration of funds, of large-scale international research programmes led by Hungarian researchers seeking to address social and economic challenges of importance to Hungary and to enhance the competitiveness of the Hungarian industry,
- supporting impact-driven research collaborations, in line with the NJP's priorities, with a strong emphasis on social and economic impact in addition to intellectual impact, and strengthening an ecosystem approach to research,
- making Hungarian researchers and institutions capable of meeting the requirements of the European research and innovation schemes and taking the role of leading their consortia,
- building trust in research and communicating research projects to stakeholders by providing scientific answers to relevant social and technological problems.

The general conditions, specific rules and additional information relating to this Call are set out in the General Application Guidelines (hereinafter the "Guidelines")¹.

Applications for funding under the focus areas of this Call are invited in the following thematic areas:

- a) Thematic areas within the focus area of supporting preventive, therapeutic and care services intended to preserve healthy life :
 - i. healthcare and disease prevention developments,
 - ii. improving quality of life of the elderly,
 - iii. innovative diagnostic and therapeutic interventions and therapies (pharmaceutical research, immunology, development of medical devices and instruments).
- b) Thematic areas within the focus area of supporting green transition of the economy and the development of a circular economy:
 - i. agricultural innovation and water management, effective protection against natural disasters and extreme weather conditions,
 - ii. increasing energy savings, accelerating the transition to clean energy, exploiting indigenous energy sources,

- iii. sustainable and smart mobility.
- c) Thematic areas within the focus area of supporting digital transformation of the economy and society:

- i. advanced cybersecurity projects and solutions,
- ii. artificial intelligence, quantum technology,
- iii. smart grids, autonomous systems.

2. AVAILABLE BUDGET

The call is financed from Title 2 (Innovation Sub-Fund) of Chapter LXII National Research, Development and Innovation Fund pursuant to Annex 1 of Act LV of 2023 on the Central Budget of Hungary for 2024.

The total budget for 2024: HUF 8,000,000,000

Funding may be granted up to the total budget available.

Foreseen number of funded projects: 20 to 80. This figure is indicative and may vary in accordance with funding requests submitted and funding won by the applicants.

3. ELIGIBILITY CRITERIA

3.1 Eligible applicants

Applications for funding may be submitted individually. For the purposes of this Call, the Hungarian organisation leading the international cooperation project specified in the application for funding is considered to be the applicant.

The call is open to legal entities with registered seat in Hungary or with registered seat in the European Economic Area and a branch office in Hungary, more specifically:

Non-profit and other non-business organisations with GFO codes 552, 563, 599 qualifying as higher education institutions recognised by the state, operating as a university and maintained by a public interest asset management foundation performing a higher-education-related public duty pursuant to Act IX of 2021 on public interest asset management foundations performing public duty.

Further conditions for applicants are set out in the Guidelines annexed to the Call.

3.2 Grounds for rejection without examination of the merits upon checking the eligibility of applications for funding

No deficiencies may be remedied, so the project proposal will be rejected without examination of the merits if:

 - 1) the application package was not submitted properly as set out in the Call,
 - 2) the applicant is subject, at the time the application for funding is submitted, to any of the grounds for exclusion laid down in any legislation, the Call or the Guidelines annexed to the Call,
 - 3) the acceptance of the application (in line with the Guidelines) was based on false/incorrect/invalid data provided in the application for funding.

3.3 Territorial restriction of the project

Not relevant for this Call.

4. DETAILED INFORMATION ON APPLICATIONS FOR FUNDING

4.1 Requirements regarding the professional content of the project

In the project, the applicant must have a cooperation with at least two research and knowledge dissemination institutions (typically a research institute or higher education institution) based in two different countries. Cooperation with foreign partners can take the following forms: subcontract or agency contract for research and development activities.

Applications for funding must include:

- a work plan describing the implementation of the project in English that demonstrates:
 - the objectives, methodology, process of the proposed innovative solution and its differentiation from existing solutions,
 - a description of the complementary competences of the applicant and at least two collaborating foreign partners, the rationale for international cooperation,
 - the expected scientific and social impacts at Hungarian and international level,
 - a work plan describing the implementation of the project,
 - a review of the Hungarian principal investigator's research and innovation achievements,
 - a research data management plan,
 - a simplified budget plan,
- a budget plan and financial schedule.

4.2 Description of eligible activities

The following activities are eligible for funding in the programme.

Activities eligible for funding independently

- I. Fundamental research²
- II. Industrial research³
- III. Experimental development⁴

Activities not eligible for funding independently

IV. Activities supporting research and development projects

4.3 Classification of eligible activities by funding category

Legal grounds of the funding: Section 28(h) of the RDI Act. The funding granted under the Call **does not constitute State aid within the meaning of EU competition law if** the applicant under section 3.1 qualifies as a **research and knowledge-dissemination organisation** within the meaning of Article 2(83) of Commission Regulation (EU) No 651/2014, and:

a) does not engage in an economic activity within the meaning of EU competition law i.e. such organisation does not engage in an economic activity that includes the production of goods and/or the provision of services in a given market; or the nature, cost and financing of the non-economic activity pursued within the project can be clearly distinguished from the economic activity of the organisation; or

b) where it also engages in an economic activity, it is directly related and strictly necessary to its core activity, it uses exactly the same inputs as its non-economic activity, furthermore the capacity allocated annually to such economic activity does not exceed 20 per cent of the total annual effective capacity of the infrastructure concerned.

Funding under this Call, to the extent that it constitutes State aid for EU competition law purposes, may be granted under the following funding categories:

For the purposes of the application of the State aid rules within the meaning of EU competition law, the statements in the relevant section of the Statements included in the application for funding is considered to be the relevant one.

The applicant shall state the amount of de minimis aid granted in Hungary to the applicant and to undertakings related to the applicant within the meaning of Article 2(2) of Commission Regulation (EU) No 2023/2831 within three years (three times three hundred and sixty-five days) preceding the award of the funding, taking into account Article 5(1) to (2) of Commission Regulation (EU) No 2023/2831⁵.

Funding decisions under Commission Regulation (EU) No 2023/2831 may only be taken after the amendments to the sections on de minimis aid of Gov. Decree 380/2014 has entered into force.

4.4 Timeframe for project implementation

Timeframe for project implementation: minimum 24 months, maximum 36 months

A milestone period may be scheduled for 12 months (only the final milestone period can be less than 12 months)

5. CORE INFORMATION ON THE FUNDING

Funding is offered in the form of a non-refundable funding, of a minimum of HUF 100,000,000 and a maximum of HUF 400,000,000 per project.

The total amount of the funding will be disbursed in the form of advance payment.

The amount of the subcontract or agency contract concluded with foreign partners for research and development activities may not exceed 50% of the total budget of the project, while at least 50% of the total budget must be used to cover the applicant's own costs.

5.1 Eligible costs

The following costs are eligible under this Call (even if the funding does not constitute State aid within the meaning of EU competition law)

I. Costs eligible under the activity 'Support for R&D project'

For funding for R&D projects the maximum funding intensity is as set out in section 1.3 of the Guidelines.


6. COMMITMENTS MADE IN THE PROJECT

6.1 Mandatory commitments

In addition to the mandatory communication activities, applicants must make and fulfil the commitments detailed below for the project as a whole:

• Publishing at least 1 publication made in international cooperation in a Q1 journal is a mandatory commitment

In addition to the publication obligation, at least two of the following conditions, linked to and covering the professional commitments, must be met in cooperation with international partners:



b) giving a lecture or presenting a poster at an international conference or participation at an international exhibition

- c) producing a unique equipment or instrument
- d) setting up a research database of measurement results
- e) developing know-how (including methodology, monitoring / evaluation model).

It is required to employ a person responsible for the project (project manager) with 0.5 FTE. Part time employment is also acceptable.

If the beneficiary fails to meet all the commitments it has made, the Technical Coordinator may, taking into account all the circumstances of the case, withdraw the funding declaration or require partial repayment of the funding. If the beneficiary fails to perform its mandatory communication activity through fault of its own, it must repay to the NRDI Fund 5 % of the funding, plus interest at the rate specified in Gov. Decree 368/2011, depending on its legal status.

The commitments must also be quantified for the relevant monitoring indicators.

In the application for funding, the application must also indicate whether it is linked to an international Research Infrastructure and, if so, the name of the Research Infrastructure and the nature of the link.

7. INFORMATION ON MAINTENANCE

This Call does not specify a maintenance period after the completion of the project.

8. SELECTION CRITERIA FOR APPLICATIONS FOR FUNDING

The project selection process covers the steps from the receipt of the application for funding to the notification of the final decision.

The ranking of the applications recommended for funding will be determined by the Research Council of Hungary, based on the ranking list set up by international peer reviewers.

Evaluation will be made in English, based on an English language evaluation form.

Evaluation criteria:

I. Potential for achieving scientific and social impact (0-5 points)

II. Excellence, uniqueness, novelty of the proposed solution and methodology (0-15 points)



III. Excellence of Hungarian and international implementing partner (0-15 points)

- scientific excellence of the Hungarian principal investigator
- international excellence of the international partner and, in the case of a higher education institution, its position in international university rankings
- quality and added value of the international cooperation
- history of cooperation between the Hungarian and international partners (number and results of previous joint projects)
- involvement of Hungarian PhD students and postdoctoral researchers
- cooperation history in Hungarian or foreign projects related to the planned research (for example projects funded by the NRDI Fund, if any)

IV. Sound, carefully planned and effective implementation plan (0-10 points)

The decision for funding will be made by the Ministry for Culture and Innovation on the basis of the recommendation of the Research Council of Hungary. Only applications supported by the Ministry for Culture and Innovation will be granted funding.

Contents of the decision on applications for funding:

- Funding granted
- Funding granted at a decreased rate
- Funding granted at a decreased rate and subject to certain conditions
- Funding granted at a decreased total cost
- Funding granted at a decreased total cost and subject to certain conditions
- Funding granted at a decreased total cost and rate
- Funding granted at a decreased total cost and rate and subject to conditions
- Funding granted subject to conditions
- Rejected for lack of funds
- Rejected

Within fifteen working days of the decision, the NRDI Office will send information on the decision through the EPTK portal pursuant to Section 73(1) of Gov. Decree 368/2011.

9. ADMINISTRATIVE INFORMATION

9.1 How to file applications for funding

To submit an **application for funding**, log in to the Participant Portal (Pályázati e-ügyintézés) at <u>www.palyazat.gov.hu</u> and complete the online application form. The finalised application form

must be submitted together with a duly signed (certified) statement verifying the electronic submission of the application, in line with the Guidelines.

The statement must be signed (certified) as follows:

- a) an authorised signatory must affix their qualified electronic signature or their qualified certificate-based advanced electronic signature or
- b) an authorised signatory must sign it by using an identification-based document authentication service (AVDH). The AVDH service is available free of charge, but requires Client Gateway (Ügyfélkapu) registration. Applications for funding may only be submitted through the Participant Portal and neither applications for funding nor statements are required to be filed on paper with the NRDI Office.

If the budget appropriations available for the grant are exhausted, or if its exhaustion is foreseeable, the submission period may be suspended or the call may be closed before the deadline for submission, of which the NRDI Office will publish information on its website. The submission period may be suspended or the call may be closed from the third day following the publication of the information notice on the NRDI Office's website. If the available budget has not been exhausted following a decision on project proposals received before the date of suspension, the suspension may be lifted and a new deadline for submission may be set.
