ON THE RULES APPLICABLE TO THE BODIES AND EXPERTS EMPLOYED BY THE NATIONAL RESEARCH, DEVELOPMENT AND INNOVATION OFFICE

Pursuant to the authorisation granted under Section 25 (5) of Act LXXVI of 2014 on Scientific Research, Development and Innovation, and in accordance with the provisions of Government Decree 344/2019 (XII. 23.) on the National Research, Development and Innovation Office and on the designation of the technical coordinator of the National Research, Development and Innovation Fund and with the provisions of Section 5 (4) and Section 39 of Annex 1 of the Instruction of the Minister of Foreign Affairs and Trade No. 8/2023 (IX. 5.) on the Organisational and Operational Rules of the National Research, Development and Innovation Office (hereinafter: "Organisational and Operational Rules"), I hereby issue the following Instruction in accordance with Section 31 (1) b) of the Organisational and Operational Rules:

I. Scope of the Instruction

- 1. The scope of the Instruction covers
 - a) the members, co-chairs and chairs of the evaluation and proposing bodies (in particular: expert groups, scientific councils, innovation boards, the Research Council of Hungary) as defined in Act LXXVI of 2014 on Scientific Research, Development and Innovation (hereinafter: "RDI Act");
 - b) experts under the RDI Act;
 - c) the members and experts of the bodies, committees and expert groups participating in the evaluation of national and European Union public funding grants managed by the National Research, Development and Innovation Office (hereinafter: "NRDI Office") in a contract under Sections 6/B (3) and 49 of the Act CXCV of 2011 on Public Finances (hereinafter: "Public Finances Act") and as a task undertaken with regard to Section 5 (1) e) to f) of Government Decree 344/2019 (XII. 23.) on the National Research, Development and Innovation Office and on the designation of the technical coordinator of the National Research, Development and Innovation Fund (hereinafter: "Government Decree");
 - d) experts involved in the qualification of research and development activities under the RDI Act.

II. General provisions

2. The members of the bodies covered by the instruction and the experts shall carry out their tasks on the basis of the invitation letter from the NRDI Office, or, in the case of a relevant provision of the RDI Act, the invitation letter from the minister responsible for science policy coordination, the agency contract and, where relevant, the purchase order.

- 3. The gross agency fees payable to body members and experts, fixed in accordance with the nature, quantity and frequency of the tasks performed, and the schedule of payment, are set out in Annex 1 to the Instructions.
- 4. The composition and number of members of the bodies covered by this Instruction must be determined in such a way as to ensure that project proposals and reports submitted in the relevant field are assessed within the appropriate time limits.
- 5. A government official of the NRDI Office may receive remuneration for the performance of the tasks under this Instruction only if the agency contract specifying the tasks expressly so provides. The agency contract may also provide for a government official of the NRDI Office to receive a lower remuneration for the performance of tasks than the remuneration specified in this Instruction.
- 6. If the remuneration under this Instruction is fixed for a period of time, and if the performance of the tasks is for a shorter period than the period for which the remuneration is fixed, the remuneration shall be pro rata temporis.
- 7. Unless otherwise provided in this Instruction, the fees fixed for the body members and experts covered by this Instruction shall include the costs of the experts' preliminary preparation, travel necessary for the performance of their tasks and all additional costs incurred in preparing the evaluation, in respect of which the body members and experts shall not receive any remuneration, allowances, flat-rate sum or reimbursement of expenses other than those provided for in this Instruction.
- 8. The rules of operation of the bodies under this Instruction shall be laid down in the rules of procedure adopted by the body and approved by the president of the NRDI Office, unless otherwise provided for in this Instruction.

III. Research Council of Hungary

- 9. The Research Council of Hungary, if so provided for in the call for proposals, is a proposing body within the meaning of the RDI Act established to assist in the development of the terms and conditions of the excellence-based research funding programmes financed from the Research Sub-fund of the NRDI Fund and to evaluate project proposals under these programmes.
- 10. The members of the Research Council of Hungary shall be appointed, nominated and revoked, and their remuneration determined, by the Minister responsible for science policy coordination, pursuant to Section 10/D (2) of the RDI Act. Members' term of office is 6 years, renewable once for a further 6 years.

- 11. The members shall perform their duties on the basis of the invitation letter and the agency contract concluded in the light of the provisions of clause 10.
- 12. The vice-president for science and international affairs or the government official acting on their behalf shall be entitled to issue performance certificates for the payment of remunerations, with the proviso that the president of the NRDI Office may designate another person to this end.
- 13. The Research Council of Hungary operates according to its self-adopted rules of procedure.
- 14. The Research Council of Hungary is supported by a secretariat. The vice-president for scientific and international affairs shall be responsible for the duties of the secretariat, subject to the provisions of the Organisational and Operational Rules.

IV. Scientific councils

- 15. Scientific councils, if so provided for in the call for proposals, are proposing bodies within the meaning of the RDI Act established to assist in the evaluation of project proposals submitted under the research funding programmes for excellence-based research financed from the Research Sub-fund of the NRDI Fund and the reports on the implementation of the funded projects. Scientific councils operate in the fields of science defined by the President of the NRDI Office.
- 16. The members of the scientific councils are proposed to the president of the NRDI Office by the head of the Research Excellence Department, through the vice-president for scientific and international affairs, subject to clause 4.
- 17. Experts invited to participate in the work of the scientific councils in order to provide specific expertise, who do not have the right to vote in the work of the councils (hereinafter: "experts with consultative rights"), may participate in the work of the scientific councils, but their number shall not exceed the number of the ordinary members of the scientific council with the right to vote, and the provisions of clause 16 shall apply mutatis mutandis to the invitation of such members.
- 18. The president of the NRDI Office invites the chairs and members of the scientific councils and the experts with consultative rights to carry out their tasks on the basis of the invitation letter and the agency contract.

- 19. The head of the Research Excellence Department or the government official acting on their behalf shall be entitled to issue performance certificates for the remunerations, with the proviso that the president of the NRDI Office may designate another person to certify the performance.
- 20. The members and the chair of a scientific council may not receive any remuneration (or must repay a proportionate part of the remuneration already paid) as follows:
 - a) if in the subject year they missed
 - aa) at least 30 but not more than 50% of the annual meetings of the council, a pro rata part of their remuneration for 2 months;
 - ab) at least 51 but not more than 70% of the annual meetings of the council, a pro rata part of their remuneration for 3 months;
 - ac) at least 71% of the annual meetings of the council, a pro rata part of their remuneration for 6 months
 - (the pro rata part of the remuneration for 1 month must be fixed in the agency contract);
 - b) if the person concerned is suspended ex officio by unilateral decision of the NRDI Office, they shall be entitled to remuneration from the date of notification or communication of the suspension only if expressly provided for in a separate agreement.
- 21. The activities of individual experts and expert groups carried out by the members of the scientific councils, with the exception of the chair, shall be governed by the rules of this Instruction applicable to individual experts and members of expert groups.
- 22. The rules for the operation of the scientific council are laid down in the rules of procedure of the scientific council approved by the president of the NRDI Office.

V. Cooperative Doctoral Council

- 23. The Cooperative Doctoral Council (hereinafter: "KDK") is a specialised scientific council which performs tasks related to the so-called Cooperative Doctoral Programme and to which the rules applicable to scientific councils shall apply with the derogations provided for in this chapter.
- 24. The members of the KDK are proposed by specific organisations and fields of science from among recognised representatives of public administration, higher education and market players with an outstanding track record in scientific research.

- 25. No experts with consultative rights may participate in the work of the KDK.
- 26. The president of the NRDI Office shall invite and appoint the chair and members of the KDK with regard to the proposal referred to in clause 24.
- 27. The vice-president for science and international affairs of the NRDI Office or the government official acting on their behalf shall be entitled to issue performance certificates for the payment of remunerations, with the proviso that the president of the NRDI Office may designate another person to this end.

VI. Forefront - Research Excellence Programme Expert Board

28. The Forefront – Research Excellence Programme Expert Board is the evaluation body established by Government Decision 1185/2017 (IV.10.) on the Forefront – Research Excellence Programme (hereinafter: "ÉSZT"), to which the rules applicable to the scientific councils shall apply, with the exception that no expert with consultative rights shall participate in the operation of the ÉSZT.

VII. The Innovation Board

- 29. The Innovation Board is a proposing body established under the NRDI Act to assist in the evaluation of project proposals and reports financed from the Innovation Sub-fund of the NRDI Fund.
- 30. The chair, co-chair and members of the Innovation Board are appointed by the president of the NRDI Office, with one member proposed by the Minister of Agriculture. The chair, co-chair and members of the Innovation Board perform their tasks on the basis of the invitation letter and the agency contract.
- 31. The vice-president for corporate innovation or the government official acting on their behalf shall be entitled to issue performance certificates for the payment of remunerations, with the proviso that the president of the NRDI Office may designate another person to this end.

VIII. Focus Area Innovation Boards

32. The Focus Area Innovation Boards are the proposing bodies set up under the RDI Act according to the fields of expertise defined in the John von Neumann Programme, which contribute to the evaluation of project proposals and reports on the funding provided from the Innovation Sub-fund of the NRDI Fund in the cases specified in the calls for proposals.

- 33. The chair and members of the Focus Area Innovation Boards and, if the president of the NRDI Office so decides, the co-chair shall be invited by the president of the NRDI Office. The chair, co-chair and members of the Focus Area Innovation Boards perform their tasks on the basis of the invitation letter and the agency contract.
- 34. The Focus Area Innovation Boards formulate their proposals for decisions in a meeting convened by the chair, which may consist of several session days. The chair and members of the Focus Area Innovation Boards and, if so decided by the president of the NRDI Office, the co-chair of the Focus Area Innovation Boards shall receive remuneration per session day as set out in Annex 1.
- 35. No remuneration may be paid to a person who is in an employment relationship with a budgetary organ or a state-owned business company, other than a contractual relationship as an agent or contractor.
- 36. The vice-president for corporate innovation or the government official acting on their behalf shall be entitled to issue performance certificates for the payment of remunerations, with the proviso that the president of the NRDI Office may designate another person to this end.

IX. Incubator Evaluation Board

- 37. The Incubator Evaluation Board is a proposing body under the RDI Act, which contributes to the evaluation of project proposals and reports on funding provided from the Innovation Sub-fund of the NRDI Fund in the cases specified in the calls for proposals.
- 38. The chair and members of the Incubator Evaluation Board and, if the president of the NRDI Office so decides, its co-chair shall be invited by the president of the NRDI Office. The chair, co-chair and members of the Incubator Evaluation Board shall perform their tasks on the basis of the invitation letter and the agency contract.
- 39. The Incubator Evaluation Board formulates its proposals for decisions in a meeting convened by the chair, which may consist of several session days. The chair and members of the Incubator Evaluation Board and, if the president of the NRDI Office so decides, the co-chair shall receive remuneration per meeting and per session day as set out in Annex 1.
- 40. No remuneration may be paid to a person who is in an employment relationship with a budgetary organ or a state-owned business company, other than a contractual relationship as an agent or contractor.

41. The vice-president for corporate innovation or the government official acting on their behalf shall be entitled to issue performance certificates for the payment of remunerations, with the proviso that the president of the NRDI Office may designate another person to this end.

X. Health Science Expert Board

- 42. The Health Science Expert Board is the proposing body for the use of the Innovation Subfund of the NRDI Fund for human medical research and clinical trials.
- 43. Members of the Health Science Expert Board are delegated by specific organisations and fields of science from among recognised experts in the field of medicine.
- 44. The chair, co-chair and members of the Health Science Expert Board shall be invited and appointed by the president of the NRDI Office with regard to the proposal under clause 43.
- 45. The head of the Department of Funding Scheme Planning and Decision Preparation or the government official acting on their behalf is authorised to issue performance certificates for the payment of remunerations, with the proviso that the president of the NRDI Office may designate another person to this end.

XI. Defence Innovation Expert Board

- 46. The Defence Innovation Expert Board is the proposing body for the use of the Innovation Sub-fund of the NRDI Fund for defence-related purposes.
- 47. Members of the Defence Innovation Expert Board are nominated by specific organisations and fields of science from among recognised experts in the field of defence.
- 48. The chair, co-chair and members of the Defence Innovation Expert Board shall be invited and appointed by the president of the NRDI Office with regard to the proposal under clause 47.
- 49. The head of the Department of Funding Scheme Planning and Decision Preparation or the government official acting on their behalf is authorised to issue performance certificates for the payment of remunerations, with the proviso that the president of the NRDI Office may designate another person to this end.

XII. Evaluation and advisory panels of the National Laboratories Programme

- 50. The evaluation and advisory tasks related to the National Laboratories Programme are carried out by the following bodies:
 - a) National Laboratories International Advisory Board
 - b) National Laboratories Supervisory Board
 - c) National Laboratories Technical Advisory Board
- 51. The chair and members of the National Laboratories International Advisory Board are appointed by the Minister for Culture and Innovation and the president of the NRDI Office.
- 52. The National Laboratories Supervisory Board is chaired by the deputy state secretary for innovation, co-chaired by the deputy state secretary for strategic affairs of the Ministry of Technology and Industry, and composed of the president of the NRDI Office and expert members. The expert members are appointed by the Minister for Culture and Innovation.
- 53. The members of the National Laboratories Technical Advisory Board are appointed by the Minister for Culture and Innovation and its chair is chosen by the members themselves.
- 54. The vice-president for scientific and international affairs or the government official acting on their behalf shall be entitled to issue performance certificates for the payment of remunerations to the chair, co-chair and members of the evaluation and advisory boards of the National Laboratories Programme, with the proviso that the president of the NRDI Office may designate another person to this end.

XIII. Other bodies

- 55. The NRDI Office shall carry out the tasks related to the budget support under Chapter XVII (Ministry of Energy), Title 20 (Chapter-managed appropriations), Sub-title 35 (Energy and sustainability tasks), Article title 4 (Chapter-managed appropriations for the energy and climate policy modernisation system) (hereinafter: "energy funding schemes"), in accordance with Section 49 of the Public Finances Act. The Energy Proposals Assessment Board is the body responsible for the evaluation of energy project proposals.
- 56. The head of the Department of Funding Scheme Planning and Decision Preparation or the government official acting on their behalf is authorised to issue performance certificates for the payment of remunerations of the members of the body under clause 55, with the proviso that the president of the NRDI Office may designate another person to this end.

- 57. The NRDI Office shall, with regard to Section 5 (1) e) and f) of the Government Decree, contribute to the policy opinion on projects submitted or to be submitted for funding under the Economic Development and Innovation Operational Programme Plus (hereinafter: "GINOP Plus") for the programming period 2021-2027. The evaluation tasks related to GINOP Plus policy opinions are carried out by expert groups with expertise in the focus areas of the projects.
- 58. The head of the Department of Funding Scheme Planning and Decision Preparation or the government official acting on their behalf is authorised to issue performance certificates for the payment of remunerations to the chair and members of the expert groups under clause 57, with the proviso that the president of the NRDI Office may designate another person to this end.
- 59. The National Research Infrastructures Committee is the decision-preparatory, proposing and opinion-forming body of the president of the NRDI Office on policy issues related to research infrastructures.
- 60. The chair and members of the National Research Infrastructure Committee shall not be remunerated for the performance of their duties.

XIV. Evaluation boards, expert groups and individual experts

- 61. Evaluation Boards are the bodies referred to in Section 10/F(1)(b) of the RDI Act, which, in the cases specified in the call for proposals, shall contribute to the evaluation of project proposals submitted to calls falling within the remit of the Research Council of Hungary.
- 62. The number of Evaluation Boards is determined by the President of the NRDI Office with the agreement of the Research Council of Hungary.
- 63. The chairs and members of each board are appointed by the President of the NRDI Office with the agreement of the Research Council of Hungary.
- 64. The rules of procedure of the Evaluation Boards shall be drawn up by the NRDI Office and approved by the president of the NRDI Office on his own authority, without the involvement of Evaluation Board members.
- 65. The expert groups will contribute to the evaluation of project proposals and reports on funding from the NRDI Fund in the cases specified in the calls for proposals.

- 66. The rules of procedure of the expert groups shall be drawn up by the NRDI Office and approved by the president of the NRDI Office on his own authority, without the involvement of the members of the expert groups.
- 67. The chairs and members of expert groups involved in the evaluation of project proposals and reports under the research funding programmes for excellence-based research funded by the Research Sub-fund of the NRDI Fund are remunerated for only one membership, even if they serve on more than one expert group at the same time.
- 68. Individual experts will be remunerated per evaluated project proposal, report, site visit or request as set out in Annex 1.
- 69. The experts supporting the activities of individual experts (hereinafter: "technology managers") shall be remunerated on the basis of the number of project proposals they manage and the number of experts they coordinate, as set out in Annex 1.
- 70. The head of the department responsible for the coordination of the evaluation task or for the management of the proposal or project or the government official acting on their behalf is entitled to issue performance certificates for the payment of remunerations for work carried out in an Evaluation Board, in an expert group or as an individual expert, with the proviso that the president of the NRDI Office may designate another person to this end.

XV. Miscellaneous provisions

- 71. The NRDI Office shall reimburse travel expenses in connection with the performance of the tasks under this Instruction in accordance with the arrangements laid down in the agency contract, in the form of a flat-rate allowance to
 - a) members of the scientific councils,
 - b) the chair and members of the Forefront Research Excellence Programme Expert Board, and
 - c) the chair and members of the expert groups under Section 25 (2) of the RDI Act
 - d) members and chairs of Evaluation Boards.
- 72. The NRDI Office shall provide accommodation and travel for up to 2 nights for the chair and members of the non-resident expert group or board for the duration of the expert group meeting, and shall reimburse travel expenses for the non-resident expert group or board member in justified cases and in accordance with the relevant instructions of the NRDI Office and the provisions of the President of the NRDI Office.

73. The NRDI Office shall provide accommodation and travel for members and chairs of the Evaluation Boards for a maximum period of one night longer than the duration of the meeting of the Evaluation Board, and shall reimburse travel expenses in justified cases, in accordance with the relevant instructions of the NRDI Office and the provisions of the President of the NRDI Office.

XVI. Closing provisions

- 74. This Instruction shall enter into force on the day of its signature, with its provisions also applying to pending cases.
- 75. Presidential Instruction No. 6/2024 on the rules applicable to the bodies and experts employed by the National Research, Development and Innovation Office is hereby repealed.
