#### Pulling it Together

#### On Interdisciplinary Research Design

This policy brief provides practice-based analysis of opportunities and obstacles relating to interdisciplinary research. It is based largely on the proceedings of the NET4SOCIETY conference "Learning by doing-making interdisciplinarity work" (Brussels, 15 January 2013), but is also informed by current literature. Reflecting a Social Sciences and Humanities perspective, its principal focus is society-driven, problem-oriented research. The Issues addressed in this policy brief, however, are relevant for all interdisciplinary research. It offers recommendations on successful programme design and project-development for policy makers, programme owners and researchers.

#### What do we need interdisciplinarity for?

Societal challenges are at the heart of the EU's Horizon 2020 Framework Programme for Research and Innovation. These challenges - which range from demographic change to resource efficiency to security - are so complex and sweeping in scope that they can only be addressed by bundling research capacities. Notwithstanding the fact that disciplinary research remains a solid contributor to knowledge generation, a more integrative strategy is needed to address grand societal challenges. We must actively seek to combine knowledge from heterogeneous sources and nurture cross-fertilization between different approaches, methodologies and disciplines. This requires a conscious effort to move beyond research silos that isolate diverse sources of knowledge. It requires a collective effort that can pave the way for critical insights and approaches and foster innovation.

#### What kind of interdisciplinarity do we need?

Interdisciplinarity is almost as hard to practice as it is to pronounce. And, like most buzz words, it often lacks clear definition and usage. Traditionally, different scientific disciplines employ specific and explicit rules on doing research. Yet they themselves are social constructs and should be versatile.

New modes of knowledge production have been gaining ground in recent years. Notably, problem-oriented research No discipline knows more than **all** disciplines.

European scholars and researchers from ICPCs might be hesitant or even skeptical with regards to the EU-FP7 as a program relevant to them, as a program they can benefit from. Dr. David Rotman the Belarusian partner in an FP7 project will prove them wrong.

Belarus, an International Cooperation Participating Country, is currently involved in several social sciences related projects funded by the European Commission.

One of these projects titled "Health in Times of Transition: Trends in Population Health and Health Policies in CIS Countries" - HITT-CIS (www.hitt-cis.net) is funded through an FP7 - HEALTH (SICA) Grant. no. 223344.

The project's approach to the topic was not to rely solely on medical statistical documents when carrying out research on health issues, but rather include national surveys, using sociological methods of collecting and analyzing the data provided by respondents. This allowed the project to create a broader view of public health situation in the CIS countries and provide informed advice to policy makers of all the countries involved.

This five years project (2009-2013) was granted € 3 million. The Project is coordinated by the Vienna Institute For Advanced Studies, and its Scientific Coordinator is the University of Aberdeen, UK.

#### **INTERVIEW**

Net4Society: Dr. Rotman, coming from a non-EU country to what do you attribute your successful participation in several EU funded projects, where you consistently play an important role? According to my personal view, it is not necessary to be educated in the EU countries to become a good scholar. I graduated

from Belarusian State University in the soviet time and then gained my practical sociological experience through active participation in the so called "all-union projects" in the 1980s. All former soviet Republics took part in these projects, and those scholars who are still in this field, continued their cooperation after the break-up of the Soviet Union. This is how I gained my expertise in organizing national surveys. Also, before I took part in FP projects I participated in several INTAS projects that had provided a very good basis for further cooperation and successful participation in FP7. In this specific HITT-CIS project I am responsible for several tasks, but in particular I consult other CIS partners on practical issues related to research

#### What is the goal of the HITT-CIS Project?

In this project, we are trying to obtain a better understanding of the circumstances in which people of the post-soviet countries live. More specifically we are studying how good or bad is the quality of health services they receive, and to what extent they can access healthcare facilities. Furthermore, our aim is to access both healthy and unhealthy people's lifestyles, patterns of nutrition, quality and type of food they usually buy and consume, as well as their habits of alcohol and tobacco consumption.

We all know that the competition between the project-proposals is very high. In your opinion, why did your project First I am proud to say that this project has been selected due to its excellence. Our consortium is working to do the best

Three features make this FP7 project especially interesting for ICPCs as well as for demonstrating the long-term benefits the cooperation enables and the flexibility within FP7 themes:

- 10 out of total 13 partners are organizations from Commonwealth of Independent States (CIS): Russia, Ukraine, Belarus, Armenia, Azerbaijan, Kazakhstan, Kyrgyzstan, and Moldova. Georgia
- It is a follow-up project that continues the research done earlier by the same partners, and thus enables to make empirical comparisons of important indicators for a longer period of time.

The Project is financed through a Health grant (SpecificTheme - Epidemiological investigations into long-term trends of population health) but the majority of the project's partners are sociological organizations, and the project's main results refer to the social sphere.

Dr. David ROTMAN from Belarusian State University -the Belarusian partner in the HITT-CIS Project was interviewed by Dr. Larissa TITARENKO the Belarusian SSH NCP and N4S member, and shared the story of
