


# MSCA DN 2024. évi felhívás

- **Újdonságok a 2024-es felhívásban:**
  - Mobilitási szabály: Country of the main activity: the country where the researcher is physically based when carrying out the main activity **and the country of the institution for which the main activity is performed (e.g., employer)**
  - **Unit contributions** felülvizsgálata: emelt (kutatói) összegek
  - **Country Correction Coefficients (CCC; országszorzők)** változása
  - **Újrabeadási korlátozás**: a következő évben 80% alatt nem lehet újra beadni, **ha a partnerek  $\geq 70\%$ -a azonos** (pontosítás)
  - **Joint Doctorates (DN-JD)**:  $\geq 1$  MS elismert közös/kettős/többes fokozatot eredményező képzés
  - **Part-time**:  $\geq 50\%$  **(kiv. eü. okból)**




# MSCA Doctoral Networks

- **Cél:** nemzetközi, interszektorális és multi- vagy interdiszciplináris együttműködés előmozdítása a doktori képzésben Európában. Magasan képzett doktorjelöltek képzése, és a vállalkozói szellem, a kreativitás és az innováció ösztönzése Európában és azon túl.
- 3 módozat:
  - **Regular DN:** a fenti célok megvalósítása doktori programba felvett PhD hallgatókkal megvalósított közös kutatási projekt révén; secondment:  $\leq 1/3$
  - **Industrial Doctorates (DN-ID):**  $\geq 50\%$  non-academic szektorban; secondment: nincs korlátozva
  - **Joint Doctorates (DN-JD):**  $\geq 1$  MS elismert közös, kettős, vagy többes fokozatot eredményező képzés; secondment: nincs korlátozva



# MSCA Doctoral Networks

- **Konzorciumi pályázat:** min. 3 intézmény, különböző MS/AC, min. 1 MS.
- **Bármilyen jogi személy** részt vehet a projektben: egyetem, kutatóintézet, cég (KKV-k is), egyéb társadalmi-gazdasági szereplők.
- **Min. 1, doktori fokozat odaítélésére jogosult partner/társult partner**
- **Futamidő:** max. 48 hónap (DN-JD: max. 60 hónap)
- **Kutatók felvétele:** 3-36 hónapra (DN-JD: 3-48 hó)
- **Projekt max. volumene:** 540 emberhónap
- **Újrabeadási korlátozás:** a következő évben 80% alatt nem lehet újra beadni, **ha a partnerek  $\geq 70\%$ -a azonos**
- **Egy ország a támogatási összeg max. 40%-át** kaphatja meg

- Doktori hallgatók felvétele **nyílt pályázat** alapján (partnerenként min. 1 PhD hallgató)
- A kutatóknak (PhD hallgatóknak) min. 1 MS/AC doktori programjába be kell lennie iratkozva (DN-JD esetén min. 2)
- Bármilyen nemzetiségű lehet
- Mobilitási szabály
- Part-time:  $\geq 50\%$  (kiv. eü. okból)

# MSCA DN: Joint Doctorate

## Joint Doctorate – Degrees



**Joint degree:** single diploma issued by at least 2 academic institutions located in 2 different countries and recognised officially




**Double/multiple degree:** 2 or more separate national diplomas issued by two or more higher education institutions located in different countries and recognised officially



**Letters of pre-agreement** to deliver joint/double doctoral degrees are mandatory in the proposal






# MSCA DN 2023: Evaluation results


