

- **Research and Innovation Action (RIA)**
- Funding rate: 100%
- **Innovation Action (IA)**
- Funding rate: 70% (non-profit organisations: 100%)
- **Coordination and Support Action (CSA)**

- Pre-Commercial Procurement (PCP)
- Public Procurement of Innovative Solutions (PPI)
- Co-Fund Partnership
- Indirect cost: 25%




WP: Rules of participation

- **Rules of participation:** Any legal entity, regardless of its place of establishment, including legal entities from nonassociated third countries or international organisations may participate in actions.
- **Funding:** member states + associated countries + USA
- Entities shall be part of a consortium that shall include at least **three independent legal entities** each established in a different Member State or associated country and with at least one of them established in a Member State (Exception: Coordination and Support Actions may be implemented by one or more legal entities, plus specific rules for Procurement Actions).



Structure of the 2-year Work Programmes:

- Introduction
 - Destination
 - Call/year (single stage and two stage calls)
 - Topics:
 - Title
 - Specific Conditions related to topic (budget, type of action)
 - Expected outcome: what should be achieved from the project
 - Scope: what should be done in the project


Innovative Health Initiative

- Single stage call: – very open – public and private actors self assemble and compete for funding



Innovative Health Initiative

- Eligibility for funding in single stage calls:




- Industry partners shall provide at least **45%** of the sum of total project eligible costs



Innovative Health Initiative

- Two-stage procedure: applicant consortia must submit a short proposal for the stage 1 evaluation; the first ranked applicant consortium will be invited to prepare and submit a full proposal for the stage 2 evaluation together with the ‘pre-identified industry consortium’.

- Up to 3 years
- 2 stage calls
- Easier application
- International evaluation
- Different countries!
- Widening actions
- Budget: **300 000 EUR**
