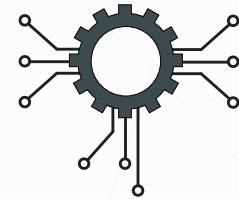

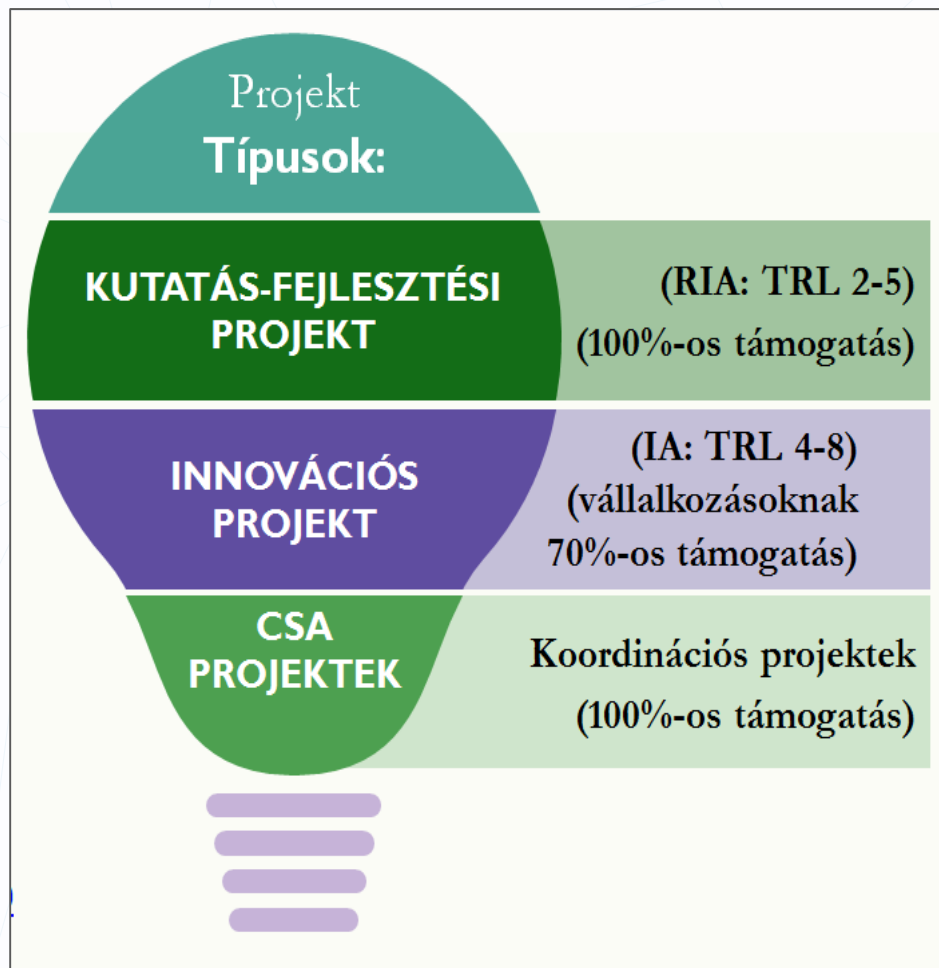

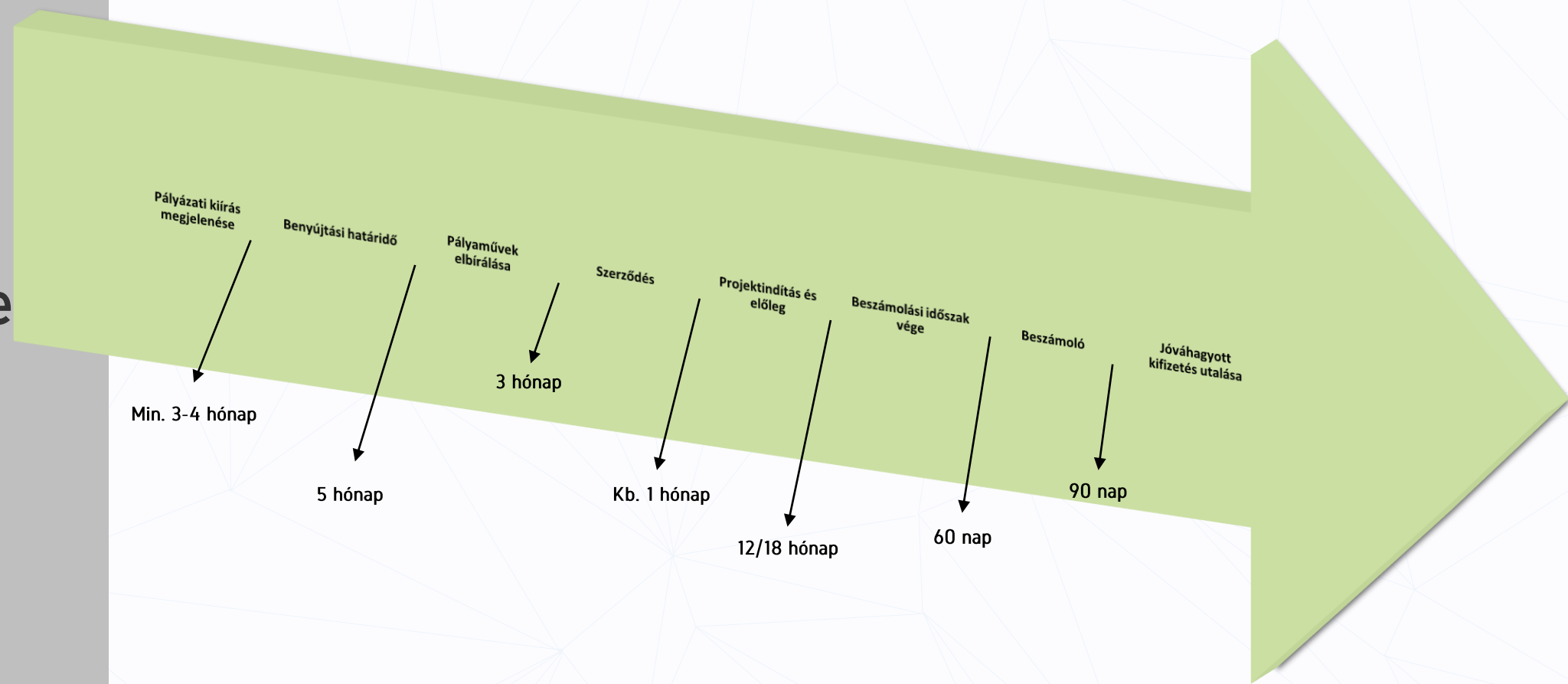
Személyi költségek elszámolhatósága

- Projekten töltött idővel arányos, ami függ a munkacsomag(ok)ban vállalt PM-től.
- Főszabály: saját munkavállaló.
- Határozatlan időre biztosított bér [+ objektív szempontrendszeren nyugvó, projekt bérkiegészítés (egységes, hazai plafont nem haladja meg)] + adó és járulékköltség.
- Két kalkulációs képlet (projektalapú és nem projektalapú bérezés megkülönböztetése)
- Órabér helyett napibér alapú számítás, naptári év megközelítés
- Havi nyilatkozat a projekten töltött napok számáról (egész vagy fél nap) VAGY továbbra is timesheet + átváltás
- Kivételek: natural persons working under a direct contract (with conditions similar to those of an employee!), kkv tulajdonos.

Projektalapú bérezés esetén...

- Megelőző lépés: HE daily rate és hazai projekt daily rate összehasonlítása
 - HE daily rate: a projekt terhére elszámolt éves (eligible!) személyi költség / az adott évben a projekten töltött napok száma
 - Hazai projekt daily rate
 - Ha van megfelelő intézményi szabályzat (egységes, összegszerű)
 - = az adott évre hatályos, az intézményi szabályzat alapján kiszámolt havi projektalapú bér x 12 / 215
 - Ha nincs megfelelő intézményi szabályzat
 - = adott évet megelőző évben kifizetett személyi költség (levonva az uniós projektekre fizetett személyi költséget*) / 215 (levonva az uniós projekteken töltött napok számát)
- * uniós projektek hatóköre még nem eldöntött

Főbb eltérések az uniós társfinanszírozású pályázatokhoz képest

- Döntő mértékben kutatói bér finanszírozás (nem beruházási célú projektek).
- (Hivatalos) munkaidő ráfordítás arányú elszámolás (nyilvántartás, Gantt-chart). Nem FTE-arányosítás.
- Tárgyi eszköz, infrastruktúra – felhasználás arányos értékcsökkenési leírás (Gantt-chart).
- Best value for money – alvállalkozás, (eszköz)beszerzés, szolgáltatás igénybevétele (intézményi szabályzat, legegyszerűbben alátámasztható: 3 ajánlat).
- 1 árfolyam / beszámolási időszak.
- Biztosíték helyett előlegből visszatartás.
- Vállalások: „deliverables” (konferencia, tanulmány, prototípus), KPI, disszemináció, eredmények védelme, hasznosítás (→ D&E&C plan).
- Ne felejtsek el betervezni: azonnali open access díja, szabadalmi ügyvivő díja, szabadalom megadásának hatósági díja, értékhatár felett könyvvizsgáló díja.
- Számlák benyújtására audit esetében van szükség, a beszámolás során nem.
- Fenntartási kötelezettség → hasznosításról történő gondoskodás kötelezettsége 4 évig.

Project results are expected to contribute to all of the following expected outcomes:

- Restoration of at least 25,000 km of free-flowing rivers, in line with the EU Biodiversity Strategy, the EU Zero Pollution Plan and the Water Framework Directive as well as other EU instruments and policies that concern freshwater ecosystem protection;

The proposals should ensure that the associated regions are located in Member States/Associated countries other than those that are part of the project consortium. An "associated region" must benefit from the Financial Support to Third Parties provided under this topic only once.]] within the project. 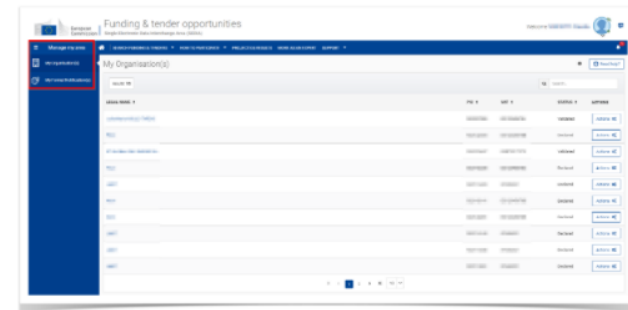

Accessing your organisation data

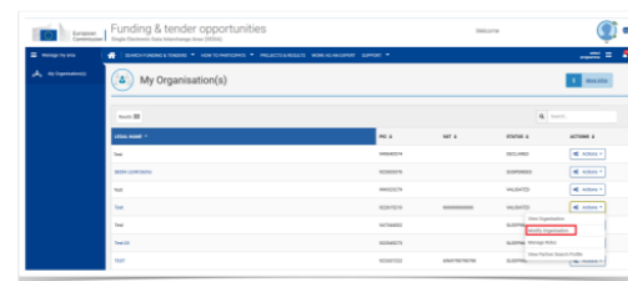
To do updates in your organisation data, upload documents or follow up your communication with Central Validation Services, follow these steps:

Access the Funding and Tenders Portal and click on **My organisation(s)** on the left. A list with all your registered organisations appears in the central part of your screen. This list also includes the organisations for which you have been appointed as contact in a proposal.



In the **Legal name** column, your registered organisations are displayed with hyperlinks. If you click on any of these hyperlinks, an overview with the main data of the corresponding organisation is shown (only if you have registered the organisation, otherwise there is no a hyperlink to the organisation page).

Select the organisation you want to update and click on the **Actions** button. Depending on whether you used the organisation in the past or you registered it, different options will be available. For organisations you registered, a modify option will be available. Click on it to access the update page.



How to Participate

Learn all that you need to apply for EU to register your organisation to how proposal, including how to manage the rights to your organisations, proposals.

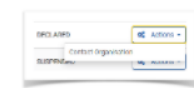
Who can edit/view the data of a non-validated organisation

For organisations which are not validated yet, i.e. cases before a LEAR role has been identified, a contact person (**Self-Registrant** role in the system) is appointed to edit/view the data of the organisation.

The person registering an organisation for first time, being granted a **Self-Registrant** role by default, will be able to manage the existing or assign additional Self-Registrant roles. Select the **Manage roles** option from the list when clicking in the **Action** button to do so, and follow the instructions as provided in the **Access management to your organisation page**.

You modify the data of the organisation by selecting **Modify organisation** from the **Action** button.

If you do not have the Self-Registrant Role, the options in the list, when clicking the Actions button, will be limited to contacting the organisation.
