ES and PL ministers have already joined the Team and Experts organised they meeting on 25th February in Budapest at the skirts of the FP7 Interim Evaluation Conference.

- 4. Well-articulated innovation strategy needed
- 5. A quantum leap needed in simplification
 - No more excuses: JUST DO IT!

- 6. Rethink mix of funding measures
 - More 'bottom up', open calls
 - Don't neglect training aspects of 'knowledge'
- 7. Consider moratorium on new instruments
- 8. Reinforce efforts on female participation
 - Galvanise Member States

 - Improve coherence with Structural Funds
- 10. Open-up better to international cooperation
